Regarding the seismic retrofit of 627 Main Street, Richmond CA, 94804

I am the owner and founder of Bay Area Retrofit, a residential seismic retrofit company that was established 25 years ago.

I am writing this letter to inform you that I personally inspected the retrofit we performed. I am happy to tell you that it exceeds the requirements for earthquake resistance found in brand new homes in your seismic zone. This included both the cripple wall retrofit and the steel column retrofit. I also performed <u>engineering</u> <u>calculations</u> to confirm this.

I examined the steel column work on the right side of the garage to make sure the design created by the engineer was meticulously adhered to. I found that the actual work precisely matched the plans drawn by the engineer.
